During the transition period (until 31 December 2020), pursuant to Article 127 (1) and (3) of the Withdrawal Agreement, Union law shall be applicable to and in the United Kingdom, shall produce the same legal effects as those which it produces within the Union and its Member States and shall be interpreted and applied in accordance with the same methods and general principles of those applicable within the Union.
